

Joint Action Plan

Accordingly with the project ***"Joint investments in the field of emergency situations for Olt County Council and Dolna Mitropolia Municipality"***, e-MS code ROBG-244, financed within the Interreg V-A Romania-Bulgaria 2014-2020 program through the European Regional Development Fund

This plan is drawn up in order to meet the objectives established by the Partnership Agreement of 20.05.2019, concluded between the Inspectorate for Emergency Situations "Matei Basarab" of Olt County and the Volunteer Organization from Dolna Mitropolia, and in accordance with the Joint Intervention Plan in the fields of competence of the General Inspectorate for Emergency Situations and the General Directorate of Firefighters and Civil Protection Bulgaria, no. 1004 / OP / 19.03.2013, as follows:

1. The joint action plan is applicable at the level of Olt County and Pleven District - Bulgaria respectively to the Inspectorate for Emergency Situations "Matei Basarab" of Olt County and Dolna Mitropolia Volunteer Organization - Bulgaria.

2. The plan shall provide a set of common harmonized standards for the management of the response to natural hazards and measures to ensure joint intervention in the event of emergencies involving the participation of some of categories of forces and means belonging to the Parties.

The joint action plan is developed in order to:

- streamlining cooperation during interventions and training activities carried out jointly by the intervention structures and the logistical support and communications structures of the parties;
- ensuring the coordination of forces and means;
- establishing the informational-decisional flow;
- establishing common notification, monitoring and intervention procedures.

This plan may be implemented in the event of the following emergencies:

- a) fires, including those of special magnitude and intensity or at the forest fund;
- b) major accidents on transport routes (road, rail, naval and aviation in the border area);
- c) major earthquake;
- d) floods;
- e) pollution of water, air and soil which are followed by contamination of the population, soil and water, with effects on environmental factors in the border area;
- f) technological accidents, including those that cause contamination with chemical, radiological and nuclear substances;

3. Responsibilities of partners:

- They will notify each other regarding the risks of natural disasters specific to each territory;
- They will collaborate in the actions of education and information of the population;
- They will organize together events / workshops (including online), related to emergency management and post-disaster reconstruction (in the case of the Inspectorate for Emergency Situations with the support of Olt County Council).

Ensuring joint intervention in the event of emergencies involving the participation of certain categories of forces and means belonging to the parties is organized in accordance with the Joint Intervention Plan in the areas of competence of the General Inspectorate for Emergency Situations and the General Directorate of Fire and Civil Protection Bulgaria, no. 1004/OP/19.03.2013.


This action plan may be amended or supplemented by the Parties by additional acts which shall become an integral part of it.
