PARTNERSHIP AGREEMENT

Signed today 20.05.2019

Having regard to

Subsidy Contract № 92955/13.08.2018 signed under project: *“Joint investments in the field of emergency situations for Olt County Council and Dolna Mitropolia Municipality”*, e-MS code: ROBG-244, financed under Interreg V-A Romania-Bulgaria 2014-2020 Programme through the European Regional Development Fund, has intervened

The following agreement concluded between

The Gendarmerie Inspectorate Olt “General army corps Constantin Dimitrescu”, address: no. 40, Cazarmii Street, Slatina, Olt County, Romania, represented by col. TUDOR-DOREL DREJOI - Chief Inspector

And

Municipality of Dolna Mitropolia, address: no. 39, St. Kiril & Metodii Street, 5855, Pleven District, Bulgaria, fiscal registration number: BG000413725, represented by POLYA VASILEVA TSONOVSKA - Mayor,

Through which the parties agreed, in free and equal conditions, the conclusion of this administrative agreement in the following terms:

1. Object of the partnership agreement

- Is the setting of the goals and responsibilities of each partner in order to implement the project *“Joint investments in the field of emergency situations for Olt County Council and Dolna Mitropolia Municipality”*

2. Partnership Agreement objectives:

- a. Active collaboration in the information and education process of the community members that they represent, regarding the types of disasters risks specific to the cross-border area Olt-Dolna Mitropolia, the action mode in the pre-disaster case - at disaster and post-disaster through:
 - Printing and dissemination of informative materials that will contain information of prevention in emergency situations (in case of The Gendarmerie Inspectorate Olt with the support of Olt County Council);

- Meetings for information and education at community level accordingly with the national strategies of both states in emergency situations.

b. Cooperation for taking preventive measures in emergency situations, and in case of disaster through the immediate intervention at the affected community level, accordingly to both parties specific attributions (in case of Dolna Mitropolia Municipality with the support of their Voluntary organization for emergency situations);

c. Collaboration, in emergency situations, for informing the affected communities regarding the immediate response and support measures, in the boundaries of each part attributions (in case of Dolna Mitropolia Municipality with the support of their Voluntary organization for emergency situations);

d. Collaboration for establishing the measures of immediate information regarding the possible evolutions at disasters risks, through the responsible institutions in this field;

e. Collaboration for improvement of the standard way of life for the population within the communities that they represent through an increased safety degree in case of disasters;

f. Collaboration in project elaboration and accessing future finance sources (in case of The Gendarmerie Inspectorate Olt with the support of Olt County Council) for the realization of the objectives of the present partnership agreement.

3. Parties responsibilities:

The two parties agree that the responsibilities are the same for each part, which have to apply the measures that emerge from the present partnership agreement in their territory where they have all the legal competences.

Therefore, the parties:

- Shall notify each other regarding the risk sources specific to each other territory, based on information received from the responsible institutions that have as their duties this attributions (in case of Dolna Mitropolia Municipality with the support of their Voluntary organization for emergency situations);
- Will collaborate within the activities of education and information for population;
- Will organize together events/workshops regarding the emergency situations management and reconstruction after disaster (in case of Dolna Mitropolia Municipality with the support of their Voluntary organization for emergency situations);
- Will cooperate within future projects related to emergency situations (in case of the Gendarmerie Inspectorate Olt with the support of Olt County Council).

4. Partnership Agreement validity:

The present agreement enters into force at the date of its signature by the Parties and is valid during the project implementation, and 5 years after that, during the monitoring period.

5. Modification, ending of agreement, litigations:

The present Partnership Agreement can be modified or completed through the additional acts, signed by both parties that will become an integrant part from it.

The ending of the Agreement is possible, at one part solicitation, through a notification made to another part in which there will be specified the reasons for this.

The eventual litigations between the two parties will be settled amicably.

The present Agreement has been concluded in 2 identical copies, in English.
